Presentation to the NJ Assembly Appropriations Committee 3/22/01

Re: A2793 / S1462

My name is Charles Engler. I have enjoyed using Spruce Run and Round Valley Recreation Areas for many years, as have many thousands of New Jersey residents.

Since the mid-eighties, the utilization of these facilities has been frequently interrupted in mid-season due to low water levels. In 1999, for example, the Spruce Run swimming area was closed in July, effectively putting a very popular park out of business, and causing serious harm to the fish populations and the environment.

Since the 90's, suggestions have been made to the NJ Water Supply Authority (which was established in 1981) to return to the cooperative plan in effect when the reservoirs were first constructed. Water was borrowed on occasion from the 55 billion gallon Round Valley reservoir during dry summers. This not only kept the park open, but also as water was pumped back into Round Valley the following spring, provided needed nutrients.

In 1998, the Friends of Spruce Run, a grass-roots group of recreationalists, sportsmen and environmentalists was formed to take more positive steps to gain acceptance of our suggested plan. Through extensive efforts, we were able to demonstrate that no harm would come to our water supply, and that the modest expense would not increase the cost of water sold to the for-profit water purveyors (this cost is about \$.02 per retail water customer per year).

From a financial standpoint, our plan will average about \$40,000 per year, some years nothing and other years more. For each added week of utilization of Spruce Run Recreation Area however, the State will receive approximately \$10,000 in admission fees, thus off-setting a portion of the pumping costs to refill Round Valley.

In return, the citizens of New Jersey, and these areas do attract people from a wide area; will once again have the use of beautiful recreation areas, for which multimillion-dollar expenditures were made. This access, in fact, was envisioned in the Water Bond act of 1958, which stated, "The reservoirs constructed pursuant to this act shall be available for public

use for recreation, swimming, fishing and boating in such manner and to such extent as shall not impair the availability of the water therein..." (58:22-16.).

Based on this promise to the people, Department of Conservation and Economic Development Commissioner Roe ordered a study made in 1966, which resulted in multimillion-dollar expenditures to create these remarkable recreation areas we have today.

A list of the groups supporting our plan is included with the material supplied. You will see that we have attracted the support of thousands.

And through the efforts of the bill's sponsors, Assemblyman Lance and Senators Schluter and Littell, and with your approval, we can return to the original operating plan of balancing our resources for the maximum benefit.

Dave sailed all his life; he grew up sailing Thistles and Penguins at West River. He got into Jets in the late fifties; some remember him crewing for Joe Willis in 540. He campaigned a MORC boat in the early 70s. He got back in Jets in 1976 when he and Doug Gregory rebuilt 729. He was a major factor in the growth and spirit of the Jet Class and the Fleet at West River from the early 80s until the present both on and off the water. He was Class President in 1982.

Dave really appreciated reminiscing with all the Jet sailors that visited with him over the past 9 months while he was confined. He would become very animated and fired up during those conversations.

Open Fleet

The Open Fleet was formed to provide an additional outlet for those skippers who wish to sail competitively. All types of boats that are not part of the Club's one-design fleets are part of the Open Fleet and are welcome to race with the club. An official start is given at the end of the starting sequence each Sunday. The Open Fleet sails a modified triangle course unless direct otherwise by the race committee. For a skipper's score to count towards qualification, the skipper must start with and sail the same course as all other Open Fleet skippers participating for the day.

Scoring will be done under the US Sailing Portsmouth Yardstick Handicapping system to make all boats equal. This system is explained in handbook under HANDICAPS. When racing with the Open Fleet, each skipper is expected to follow the one-design class rules and specifications that govern the type of boat being raced at that time. When qualifying for a series, a skipper need not race the same type of boat for the entire series. Regardless of the number of boat types used, a skipper's entire participation in the series will be used to determine his/her final standing and minimum participation requirement.

A MID-WINTER ODYSSEY

This year's Mid-Winters started on the Wednesday of the last week in February with the Force 5's at the Upper Keys Sailing Club in Key Largo. Three days of fine weather and good winds on Buttonwood Bay.

Rich Baumann and I enjoyed the sailing but could not put together a good series and ended in the lower portion of the fleet of 16 boats. Rich's question, "It the competition tougher than we're used to?"

Boat Storage Selection Procedures and Regulations

The State Park Service provides 300 boat storage spaces at Spruce Run Recreation Area. Please read the following selection procedures and regulations before completing the attached application.

Selection Procedures:

- Applications will only be accepted beginning March 1st. Storage sites will be assigned consecutively on a first come first served basis beginning with site number one until the first 300 applications have been satisfied.
- After the first 300 applications are received, any remaining applications will be placed on a waiting list in the order in which they were received. Any vacancies resulting from cancellations will be awarded from this list.
- The first 300 applicants will be issued a permit through the mail. All remaining applicants will be notified of their waiting list number through the mail.
- Required refunds will be processed through the State Treasurer's Office.

Regulations:

- The boat storage season extends from April 1st through October 31st.
- Stored boats are limited to a length of 25 feet and a maximum height of 30 feet above the water line.
- Stored boats must be removed from the water and placed in assigned storage spaces each night.
- Boat storage sites will be assigned consecutively on a first come first served basis beginning with site number one.
- Boat storage permits are not transferable.
- Possession of a boat storage permit will not guarantee admission to the boat launch peninsula when the area
 is full.
- Issued boat storage decals must be permanently affixed to each stored boat and vehicle.
- Stored boats greater than 12 feet in length (except canoes and kayaks) or motor powered boats (regardless of length and type) must display a current New Jersey registration number and sticker.
- The State of New Jersey and its employees or agents are not responsible for the protection of boats or any equipment stored and is not liable if vandalized, damaged or stolen.
- The State of New Jersey reserves the right to discontinue boat launching for special events or, if in its opinion, the reservoir level reaches an elevation which is considered unsafe for boating or boat launching. The State Park Service is not responsible for, nor guarantees, the water level at the reservoir during the boat storage season.

- If a boat storage permit is destroyed, damaged or lost, a replacement permit may be issued. To receive a replacement, proof of the lost, damaged or stolen permit is required by providing permit remnants, police reports for stolen or damaged vehicle/boat or any other documentation that provides reasonable proof of loss or damage.
- The boat storage fee includes the daily parking fee for one vehicle. Vehicle decals must be permanently affixed to the permittee's vehicle or the daily parking fee will be charged.
- Cancellations and refund requests for a boat storage permit will be prorated and require a \$20 cancellation fee.
- Boat storage permit holders will not make use of the Spruce Run Boat Storage Area contrary to park regulations.
 Violators may be subject to penalties under NJAC 7:2-2.13. A full text of rules is posted and is available upon request.


