Hunterdon Sailing Club — Sail Training Programs

For many years, the Hunterdon Sailing Club has provided Sail Training Programs at Spruce Run each sailing season. Below is a description of the Sailing Programs offered during the current year.

Youth - Learn to Sail Price \$50.00 per session

The Youth Learn to Sail program is a three-day class that introduces children to sailing. The class is offered to children that will be at least 10 years old during the current calendar year. The class is taught on Sunfish sailboats with two children sailing on one boat. The class is held on three consecutive days from 9AM to 3PM. Each child must bring and wear a life jacket and a tee shirt. Upon completion of the course, each student should have a basic understanding of the parts of a sailboat, know how to rig and unrig a sailboat and be proficient at sailing upwind, downwind and off the wind. Students will also learn basic nautical terms and water s afety.

Youth – Performance Sailing Price \$50.00 per session

The Youth Performance Sailing program is a three-day class that improves and enhances a student's sailing capabilities. The class is taught on Sunfish sailboats with each child sailing the boat single-handed. The class is held on three consecutive days from 9AM to 3PM. Each child must bring and wear a life jacket and a tee shirt. Upon completion of the course, each student should have an understanding of sailing rules, courses used for racing, and enhanced techniques to improve speed and performance on the water. Each student should be skilled and capable of sailing solo on Wednesday nights or Sunday afternoons in HSC scheduled events.

Introduction to Sailing FREE with Membership

Introduction to Sailing is offered to adult members. The course consists of an evening lecture on sailing and a one half-day session on-the-water. The on-the-water session occurs on a Saturday in June. Students are assigned to the morning or afternoon session. Members of HSC will provide a variety of sailboats and provide on-the-water instruction that will reinforce the classroom lecture. The class is FREE to members but we limit attendance to at most two (2) adults per membership household.

Adult – Learn to Sail / Performance Sailing

Price \$50.00 per session

The Adult Learn to Sail / Performance Sailing is a three-day class that should develop a student to be comfortable (perhaps proficient) at sailing. The class is taught on Sunfish sailboats and each student will sail the boat single handed. The class will be offered on a Thursday and Friday evenings (5PM to 8PM) and on Saturday from 10 AM to 4PM. Students will be divided based on their skills but by the afternoon of the last day all students will be sailing together. After completion of this course each student should be skilled and capable of sailing solo on Wednesday nights and Sunday afternoons in HSC scheduled events.

Note: The above sailing classes are offered using Sunfish sailboats. Students (adult and youth) are asked to bring their own Sunfish if they have one. However, members of the Hunterdon Sailing Club loan their Sunfish to us for these classes. Please be considerate of the property (boats, sails, etc.) that are offered for these classes. These classes are not recreation, nor are the meant to be Summer camp. The members that serve as instructors donate their time (and in many cases paid vacation) to make these events happen. Therefore, we encourage learning and seek to improve each student's abilities. Continued on next page

COMMODORIE'S CORNIER

Spring is just around the corner and it's time to reserve your boat spot at Spruce Run and also to send in your HSC Membership application for 2001. This year the membership application has grown such that it requires two pages (page 3 & 4 of the newsletter). The reason is because the Executive Team has planned several new training opportunities for Adults. Members can attend an "Introduction to Sailing" Lecture / On The Water training. There is no cost for this class and it is included as part of your Membership. This class has been offered for the last several years. In addition, HSC will offer Adult Learn to Sail / Performance Sailing. This is a new class that will be offered on a Thursday / Friday evening and ALL DAY on that Saturday (following day). This class will be held in Sunfish and is intended to make people proficient sailing Sunfish. After completing this class, Adults should be comfortable in a Sunfish and be capable of participating in Wednesday and Sunday sailing events. The three day session will cost \$50.00 per Adult. Class size is limited so sign up early. The Executive Team has also scheduled Sunfish Clinics that will be taught on Sunday Mornings. These clinics will address specific needs of the Students. For example, clinics may be devoted to starting techniques, covering, tacking & gybing etc. The purpose of the clinics are to help members hone their sailing skills. Clinics will cost \$10.00 per session.

Training Programs cont.

Sailing Clinics will be offered in June and July on Sunday Mornings. Each instructor will supervise up to three or four students. The clinics are held in Sunfish and each student is responsible for bringing or borrowing a Sunfish. The purpose of the clinics are to improve and enhance sailing capabilities to maximize speed on the water. Also, students will learn some of the rules of sailing and techniques to maximize their use during racing. Typical clinics will cover: set up of the sailboat for maximum speed, sail position and trim in various wind conditions, covering and passing including covering from behind, starting techniques including the bold "port tack start", determining the "favored end", seeing puffs on the water and planning youe next action, mark roundings, roll tacks, split tacks, and more.

Albacore Fleet Report

So what is an Albacore, and why is it gaining in popularity? I can't say it any better then this guy, Barney Harris. Barney is the North American Albacore Champion and a great friend of sailing, enjoy!

What is an Albacore by Barney Harris

My long time 505 crew asked me just that - I thought for a minute and told him that "...it is a cross between an Interclub dinghy and a 505" — both boats with which he is intimately familiar. With rounded bilges and a plumb bow, the 240 lb Albacore hull resembles a 15-foot Thistle. A deep, airfoil section centerboard and rudder make the Albacore exceptionally maneuverable. The Albacore's rig uses swept spreaders supporting a tapered mast, a powerful vang, and adjustable jib halyard and other sail controls to depower in high winds enabling both light and heavy crews to race head to head in all but the most extreme conditions. The powerful, rig and easily driven hull give excellent performance over a wide range of conditions. The Albacore is a boat that is both simple to get into at first, and one which will challenge your tuning and tactical skills for the rest of your life.

The real proof is in the sailing. The Albacore is a great first boat for those who are just learning to sail and a very competitive racer for more advanced sailors. While the Albacore is a fast and lively boat, it is relatively easy to get up to speed and the racing is very tactical. A very versatile boat, it is often sailed by husband/wife and parent child combinations. Some of the all women teams are the most competitive in the class. Albacore sailors comprise an eclectic group from all ages and walks of life including students, professionals, senior executives, and retirees ranging in age from 15 to 71.

The Albacore is raced in the Potomac, Virginia, Maryland, New York, Florida, New Jersey, and several provinces in Eastern Canada, as well as in the United Kingdom, Ireland, and Cypress. In particular, the Albacore is well represented at events on the one design regatta circuit.

A well-attended series of National and International champ ionships serves to satisfy the competitive urges for hard-core racers. The Albacore is currently raced in seven countries, and a World or International Championships is held every two years. In 1999, the International Championships was hosted in the United States at the Rehoboth Bay Sailing Association in Delaware. This was a weeklong event from October 9 — 15, 1999 with 66 teams participating. This year, 2001 the Albacore Championships will be held in Torbay, Great Britain with over 70 teams anticipated to attend. Getting Started in the Albacore Class

Over 30 new Albacores were built in North America alone during the past year for new owners in Canada and the United States. Ontario Yachts is the primary North American builder. They build a great boat with simply equipped standard models going for about US\$5,600 and top competition models incorporating modern sandwich composite construction, fully fitted out with top quality fittings and ready to race for around US\$7,000, including sails.

A second hand boat is a great way to get started on a tight budget. Competitive racing boats in good condition sell for around \$3,800 and a good starter boat can be purchased for \$1,500 or less. Many Albacores will have a competitive life of well over 15 years, and there several 20 to 40 year old boats that regularly place at the top of the fleet. Campaigning an Albacore is economical: new sail purchases are limited to one per year by Class rules, and are typically done in groups to keep costs down. Much of the racing is at venues where camping is possible and the boat can be trailered behind a small car.

The real proof is in the sailing. While the Albacore is a fast and lively boat, it is relatively easy to get up to speed and the racing is very tactical. Albacore class members comprise an eclectic group from all ages and walks of life including students, professionals, senior executives, and retirees who range in age from 15 to 71. One Albacore is currently owned by a member of the US Senate. Truly, there is something in the Albacore for everyone who loves sailing.

Boat Storage Selection Procedures and Regulations

The State Park Service provides 300 boat storage spaces at Spruce Run Recreation Area. Please read the following selection procedures and regulations before completing the attached application.

Selection Procedures:

- Applications will only be accepted beginning March 1st. Storage sites will be assigned consecutively on a first come first served basis beginning with site number one until the first 300 applications have been satisfied.
- After the first 300 applications are received, any remaining applications will be placed on a waiting list in the order in which they were received. Any vacancies resulting from cancellations will be awarded from this list.
- The first 300 applicants will be issued a permit through the mail. All remaining applicants will be notified of their waiting list number through the mail.
- Required refunds will be processed through the State Treasurer's Office.

Regulations:

- The boat storage season extends from April 1st through October 31st.
- Stored boats are limited to a length of 25 feet and a maximum height of 30 feet above the water line.
- Stored boats must be removed from the water and placed in assigned storage spaces each night.
- Boat storage sites will be assigned consecutively on a first come first served basis beginning with site number one.
- Boat storage permits are not transferable.
- Possession of a boat storage permit will not guarantee admission to the boat launch peninsula when the area
 is full.
- Issued boat storage decals must be permanently affixed to each stored boat and vehicle.
- Stored boats greater than 12 feet in length (except canoes and kayaks) or motor powered boats (regardless of length and type) must display a current New Jersey registration number and sticker.
- The State of New Jersey and its employees or agents are not responsible for the protection of boats or any equipment stored and is not liable if vandalized, damaged or stolen.
- The State of New Jersey reserves the right to discontinue boat launching for special events or, if in its opinion, the reservoir level reaches an elevation which is considered unsafe for boating or boat launching. The State Park Service is not responsible for, nor guarantees, the water level at the reservoir during the boat storage season.

- If a boat storage permit is destroyed, damaged or lost, a replacement permit may be issued. To receive a replacement, proof of the lost, damaged or stolen permit is required by providing permit remnants, police reports for stolen or damaged vehicle/boat or any other documentation that provides reasonable proof of loss or damage.
- The boat storage fee includes the daily parking fee for one vehicle. Vehicle decals must be permanently affixed to the permittee's vehicle or the daily parking fee will be charged.
- Cancellations and refund requests for a boat storage permit will be prorated and require a \$20 cancellation fee.
- Boat storage permit holders will not make use of the Spruce Run Boat Storage Area contrary to park regulations.
 Violators may be subject to penalties under NJAC 7:2-2.13. A full text of rules is posted and is available upon request.
